## **COUNCIL MESSAGE**

The last couple years have presented all of us with many challenges with the effects of the Pandemic reaching across our communities. With the recent changes and evolution of the Provincial Government Covid guidance it appears we may be coming out of the darkest of these challenges and the spring is looking much brighter for many of us. We believe that this Spring/Summer our Summer Village residents will be able to return to a more normal tight knit community where we can mix and mingle with our neighbors in a more relaxed calm atmosphere. Over the last few months there have been several reports of unlawful activities throughout our village including break and enters, theft and vandalism. We would ask everyone to be vigilant and to report any suspicious activities or vehicles to the RCMP as soon as possible. This will help protect our neighbors and our own properties in the future.

We hope that over the summer each of our residents will have the opportunity to make full use of their lake lots and all our community amenities to create many new family and friend's memories.

## WASTEWATER UPDATE

The Wastewater System continues to operate well. So far this winter, there has only been one call out for our system operator.

The 2022 Maintenance program will include inspection and servicing of air relief valves, exercising system and cc valves, and a sample inspection of the wear and tear on pump grinder blades. The Summer Village will also be looking at the air relief valve manholes to select the process for sealing the manholes to prevent leaking.

Also, in compliance with the Wastewater Utility Bylaw, properties that were identified as having holding tanks that were in a fair to poor condition will be inspected this year at homeowner cost. Residents with tanks requiring inspection will be notified later this spring.

Our system operator THS Septic and Civil Solutions is ready to answer any questions or respond to any concerns you may have. Please contact them as follows:

An emergency is a spill or release of wastewater outside the system and must be reported immediately. Other concerns such as high-level alarms can be reported to THS at any time.

Please remember your grinder pump will provide years of service if you follow some simple rules. The only materials permitted to be discharged into the wastewater system are: human waste and toilet paper; greywater from showers, sinks, tubs and dishwashers; conventional food wastes as processed through an in-sink garbage disposal unit and laundry machine washing discharge.

Many items are not allowed to enter toilets or drains. Prohibited items include:

"flushable" baby wipes	dental floss	gravel	socks, rags or cloth
feminine products	pantyhose	bones	paint or paint thinner
diapers	plastics / latex	glass	metal
condoms	grease or cooking oil	sand	cat litter
egg shells	seafood shells	grout	cleaning wipes

Sump pump discharge, rainwater and other surface water are not permitted to enter the wastewater system. In addition, Schedule D-1 and D-2 in the Municipal Wastewater Utility Bylaw #253 set out chemical, oil, flammable materials and other restrictions.

NOTE: The cost of repair to the grinder pump caused by prohibited materials in the tank will be the responsibility of the property owner.

## **HE (HIGH EFFICIENCY) FURNANCES**

<u>Friendly Reminder</u>: HE (High Efficiency) furnaces can freeze lines between the wastewater tank and the dwelling, please consider installing a condensate pump if you have a HE furnace to help resolve this potential issue.

## NEW SOLID WASTE PROGRAM

GFL will be offering Poplar Bay residents a new solid waste and recycle program. Residents will be receiving a new garbage bin to replace bins they are currently using. Recycling will also now be an option bi-weekly for the months of May to October. Stay tuned to the website <u>www.poplarbay.ca</u> for the solid waste and recycle collection schedule.

#### POPLAR BAY LAND USE BYLAW

Council will be engaging with Municipal Planning Service (MPS) to review and revise the Land Use Bylaw; more information to come regarding this soon.

## ROADS AND DRAINAGE

Last fall we undertook a large program to repair sections of our roads, as well as to improve drainage through a ditch recontouring and culvert replacement program. The total cost of the program was \$463,218.00 with most of the work completed late in the fall. The final inspections and any repair or modifications will be completed this spring after the spring runoff has finished. Any future road work will be affected by the funding changes that are highlighted in section Capital Grant Program Update in this newsletter.

## CAPITAL GRANT PROGRAM UPDATE FROM PROVINCE

As part of Budget 2021, the government had to make difficult decisions to keep spending under control while supporting local governments. There will be limited resources given out for roads, and seeking alternate funding will need to be an option moving forward.

## **MSI Capital**

For both 2022 and 2023, every municipality and Metis Settlement is estimated to receive 40.6 per cent of what they received in 2021. This reduction is equivalent to the year over year change in the MSI capital budget from \$1.196 billion to \$485 million, and ensures the reduced budget will impact every local government equally.

## **MSI Operating**

To provide stability in operating funding, MSI operating allocations will be frozen at the 2021 level for both 2022 and 2023. Every municipality and Metis Settlement will receive the same amount of operating funding for the next two years as they received this year.

### BOAT MOORING DISTURBANCE STANDARD

Last Spring, Alberta Environment and Parks created a new Boat Mooring Disturbance Standard for temporary seasonal docks and other mooring structures. If you are placing a structure on municipal land, you will require approval from the Summer Village of Poplar Bay. #### FIREWORKS

Council is looking for some input from our residents regarding the use for Fireworks within our Municipal Boundaries. Council has been approached by many suggesting a Ban on Fireworks and as a result we have decided to ask residents to provide us with their thoughts around the creation of a Fireworks use Bylaw for our Village. #### ROAD WEIGHT RESTRICTIONS AND SPEED ENFORCEMENT

Council is currently working with several of our neighboring communities to create a more unified and collaborative approach to enforcing our current road bylaws around weight restrictions and speeding. This will result in our community being better equipped to enforce speeding infractions through policing as well as better protect our roads from overweight loads.

We are looking to have RCMP, Alberta Sheriffs and Peace Officers to have regular radar enforcement activities along our roads, these would be radar stops not photo and as a result a citation and demerit points would be issued which will affect your vehicle insurance costs. Alberta is one of only a few provinces where fines increase for each km/hr over the limit, and there is no minimum overage. There is a belief that no tickets are issued at less than 10km/hr over the posted limit. This is however not correct as tickets can be issued for any overage that is recorded. It is likely there would be a zero tolerance on our roads, which would mean any vehicle traveling over 30km/hr in summer would be stopped and a citation issued.

#### In Alberta the following is the enforcement guide:

1-15km/hr over limit = 2 demerit points, \$78 to \$120 based on speed over 16-30km/hr over limit = 3 demerit points, \$140 to \$239 based on speed over Speeding is an ongoing concern for many of our residents as speeding affects the safety of our people, children, and pets. We would encourage all our residents to closely observe the limits and to please ensure anyone coming to visit you is aware of the speed limits.
